OCTOBER 27TH 1942 (CALLED MEETING)

THE BOARD OF TRUSTEES OF THE TOWN OF FORT BRANCH MET IN SPECIAL SESSION WITH ALL MEMBERS PRESENT.

AND NOW TRUSTEE MEYER PRESENTS AN ORDINANCE AND MOVES THAT SAID ORDINANCE BE READ FOR THE FIRST TIME WHICH SAID ORDINANCE ENCLUDING IT'S TITLE IS IN WORDS AND FIGURES FOLLOWING:

AN ORDINANCE PROHIBITING THE MARKING ON OR DE* FACING OF WINDOWS WITHIN THE CORPORATE LIMITS OF THE TOWN OF FORT BRANCH INDIANA, AND PROVID* ING PENALTIES FOR THE VIOLATION THEREOF:

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF FORT BRANCH, INDIANA THAT

SECTION 1

IT SHALL BE UNLAWFUL FOR ANY PERSON OR PERSONS TO MARK ON, DEFACE OR DESTROY ANY DOOR, WINDOW OR WINDOWS WITHIN THE CORPORATE LIMITS OF THE TOWN OF FORT BRANCH, INDIANA, OWNED OR POSSESSED BY ANOTHER PERSON OR PERSONS, BY PLACING THEREON AND SOAP, PARAFFIN OR OTHER SUBSTANCE WHATEVER.

SECTION 2

ANY PERSON OR PERSONS WHO SHALL VIOLATE ANY OF THE PROVISIONS OF THIS ORDINANCE SHALL ON CONVICTION THEREOF BE FINED IN ANY SUM NOT EXCEEDING ONE HUNDRED DOLLARS (\$100.00) TOGETHER WITH THE COSTS OF PROSECUTION TO WHICH MAY BE ADDED IMPRISONMENT IN THE COUNTY JAIL FOR A PERIOD NOT EXCEEDING TEN (10) DAYS.

SECTION 3

THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT FROM AND AFTER ITS PASSAGE AND THE POSTING UP OF COPIES OF THE SAME IN EACH WARD OF SAID TOWN.

IT S TITLE IS IN WORDS AND FIGURES FOLLOWING:

AN ORDINANCE PROHIBITING THE MARKING ON OR DE*

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF FORT BRANCH, INDIANA THAT

SECTION 1

IT SHALL BE UNLAWFUL FOR ANY PERSON OR PERSONS TO MARK ON, DEFACE OR DESTROY ANY DOOR, WINDOW OR WINDOWS WITHIN THE CORPORATE LIMITS OF THE TOWN OF FORT BRANCH, INDIANA, OWNED OR POSSESSED BY ANOTHER PERSON OR PERSONS, BY PLACING THEREON ANDY SBAP, PARAFFIN OR OTHER SUBSTANCE WHATEVER.

SECTION 2

ANY PERSON OR PERSONS WHO SHALL VIOLATE ANY OF THE PROVISIONS OF THIS ORDINANCE SHALL ON CONVICTION THEREOF BE FINED IN ANY SUM NOT EXCEEDING ONE HUNDRED DOLLARS (\$100.00) TOGETHER WITH THE COSTS OF PROSECUTION TO WHICH MAY BE ADDED IMPRISONMENT IN THE COUNTY JAIL FOR A PERIOD NOT EXCEEDING TEN (10) DAYS.

SECTION 3

THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT FROM AND AFTER ITS PASSAGE AND THE POSTING UP OF COPIES OF THE SAME IN EACH WARD OF SAID TOWN.

AND NOW THE ROLL IS CALLED AND GWALTNEY, MEYER AND BERLIEN ALL VOTE AYE AND SAID ORDINANCE IS READ BY THE CLERK. TRUSTEE BERLIEN MOVES THAT THE RULES BE SUSPENDED AND THAT SAID ORDINANCE PASS TO ITS SECOND READING AND THAT THE SAME BE READ BY TITLE ONLY AND NOW ON THE ROLL CALL, GWALTNEY, MEYER AND BERLIEN EACH VOTE "AYE". AND NOW UNDER THE SUSPENSION OF THE RULES TRUSTEE MEYER MOVES THAT SAID ORDINANCE BE PLACED ON ITS FINAL PASSAGE AND PASSED. AND NOW THE ROLL IS CALLED AND GWLATNEY, MEYER AND BERLIEN EACH VOTE "AYE" AND NOW THE PRESIDENT OF THE BOARD OF TRUSTEES DECLARES SAID ORDINANCE PASSED AND ADOPTED.
