

Ordinance No. 1961-1

AN ORDINANCE FIXING SPEED LIMIT FOR TRAINS
PASSING THROUGH THE LIMITS OF THE TOWN OF
FT. BRANCH

BE IT ORDAINED BY THE TOWN BOARD OF THE TOWN OF FT. BRANCH,
INDIANA AS FOLLOWS:

SECTION 1. All railroad trains passing through the limits
of the Town of Ft. Branch, Indiana shall travel at a rate of speed not
exceeding forty (40) miles per hour.

SECTION 2. This ordinance shall repeal all other ordinances
of the Town of Ft. Branch, Indiana in conflict herewith.

SECTION 3. Every person found guilty of violation of any
provision of this ordinance shall be punished by a fine of not less than
ten dollars (\$10.00), nor more than twenty-five dollars (\$25.00).

SECTION 4. This ordinance shall be in full force and effect
from and after its passage by the Town Board and due publication as by
law required.
