

ORDINANCE 1972-2

AN ORDINANCE ADOPTING THE PROVISIONS OF CHAPTER 138, ACTS OF 1957, AS AMENDED, INDIANA GENERAL ASSEMBLY, FIXING THE TIME FOR THE ESTABLISHMENT OF AN AREA PLANNING DEPARTMENT, AND PROVIDING FOR THE APPOINTMENT OF A REPRESENTATIVE OF FORT BRANCH, INDIANA, TO THE AREA PLAN COMMISSION.

WHEREAS, Chapter 138, Acts of 1957, as amended, Indiana General Assembly, provides for the establishment of area planning departments in any county of the State adopting the provisions of said Act; and

WHEREAS, a single planning operation for Gibson County would encourage all units of government to cooperatively work together for the improvement of the health, safety, convenience and the welfare of the citizens of the county and would encourage the proper public and private development of the region in the best interests of all governmental units concerned; and

Whereas, the Board of County Commissioners of Gibson County did on the 5th day of September, 1972, by Ordinance Number 1972-1 establish the Area Plan Commission of Gibson County under the authority provided in Chapter 138 of the Acts of 1957, as amended, Indiana General Assembly; and

WHEREAS, Chapter 138, Acts of 1957, as amended, Indiana General Assembly, provides for the establishment of area planning departments in any county of the State adopting the provisions of said Act; and

WHEREAS, a single planning operation for Gibson County would encourage all units of government to cooperatively work together for the improvement of the health, safety, convenience and the welfare of the citizens of the county and would encourage the proper public and private development of the region in the best interests of all governmental units concerned; and

Whereas, the Board of County Commissioners of Gibson County did on the 5th day of September, 1972, by Ordinance Number 1972-1 establish the Area Plan Commission of Gibson County under the authority provided in Chapter 138 of the Acts of 1957, as amended, Indiana General Assembly; and

WHEREAS, as provided in Section 4 of said Act, the Town of Fort Branch desires to participate in the establishment of an area planning department.

NOW THEREFORE BE IT ORDAINED by the Board of Town Trustees of the Town of Fort Branch, Indiana; that:

SECTION 1. It is the declared intention of the Board of Town Trustees of the Town of Fort Branch, Indiana, to avail itself of

SECTION 4. A copy of this Ordinance, upon its passage and signature by the members of the Board of Trustees shall be certified to the Board of County Commissioners of Gibson County, Indiana and to the following Cities and/or Towns of Gibson County, Indiana: Princeton, Oakland City, Owensville, Haubstadt, Francisco, Patoka, Somerville, Mackey, and Hazleton.

SECTION 5. This Ordinance shall be in full force and effect from and after the 15<sup>th</sup> day of NOVEMBER, 1972.
