

**ORDINANCE NO. 2021 - 8**  
**AMENDMENT TO ORDINANCE 2021-4**  
**NO PARKING AND LIMITED PARKING**

**WHEREAS**, the Town Council of Fort Branch wishes to amend Ordinance No. 2021-4, “NO PARKING ZONE” for Locust Street from McCreary Street to West Street;

**WHEREAS**, The Town Council desires to make a portion of Locust Street a “LIMITED TIME PARKING” to accommodate business along that portion of the roadway;

**NOW THEREFORE LET IT BE ORDAINED:**

**SECTION 1:** The Town Council has the power and authority to regulate parking along its platted streets and to amend ordinances of the Town of Fort Branch;

**SECTION 2:** The Town Council believes it is in the best interest and health and safety of its citizens to establish a “LIMITED TIME PARKING” area along a portion of West Locust Street;

**SECTION 3:** Parking spaces from the corner of West Locust Street and the west side of North McCreary Street for a distance of thirty (30) feet from the Stop Sign, north along the west side of McCreary Street shall be designated as “NO PARKING”;

**SECTION 4:** Section 4 of Ordinance 2021-4 shall be amended to read as follows:  
**Section 4, Ordinance No. 2007-6 “Unloading Zone” shall be terminated. Locust Street from Highway 41 to McCreary Street is “NO PARKING” on either side of the street. The portion of Locust Street from McCreary Street to the driveway entrance to 210 West Locust Street will be “NO PARKING” on either side of the street, the section of Locust Street from the driveway entrance to the west boundary of 208 West Locust Street will be “30 MINUTE PARKING” on the north side of Locust Street, the south side of Locust Street will remain “NO PARKING” to West Street.**

**SECTION 5:** Section 5 of Ordinance 2021-4 shall be amended to read as follows:  
**Section 5, The “NO PARKING” and “LIMITED PARKING” spaces defined above shall be posted by signs and marked in accordance with Indiana Code.**

**SECTION 6:** Section 6 of Ordinance 2021-4 shall be amended to read as follows:  
**Section 6: Any person/persons who park in a space designated as “NO PARKING” in the areas defined herein shall be fined Fifty Dollars (\$50.00), payable to the Town of Fort Branch. Any person/persons who park in a space designated as “30 MINUTE PARKING” in the areas defined herein for a time greater than posted shall be fined Fifty Dollars (\$50.00), payable to the Town of Fort Branch.**

**SECTION 7:**
