**A RESOLUTION OF THE TOWN COUNCIL OF THE  
TOWN OF FORT BRANCH, INDIANA  
AUTHORIZING SUBMISSION OF COVID-19 PHASE 2  
PROGRAM APPLICATION**

**WHEREAS**, the Town Council of Fort Branch, Indiana recognizes the need to stimulate growth and maintain a sound economy within its corporate limits; and

**WHEREAS**, the Housing and Community Development Act of 1974, as amended, authorizes the Indiana Office of Community and Rural Affairs to provide grants to local units of government to distribute to small businesses for the job retention; and

**WHEREAS**, the Town of Fort Branch, Indiana has conducted or will conduct public hearings prior to the submission of an application to the Indiana Office of Community and Rural Affairs in order to assess the housing, public facilities, and economic needs of its low-income and moderate-income residents;


NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Fort Branch, Indiana as follows:
