

AN ORDINANCE OF THE TOWN OF FORT BRANCH, INDIANA  
 FIXING THE COMPENSATION FOR THE ELECTED OFFICIALS  
 AND ALL APPOINTED EMPLOYEES FOR THE TOWN OF FORT  
 BRANCH, WATER AND SEWER UTILITIES FOR THE FISCAL YEAR  
 BEGINNING JANUARY 1, 1979 AND ENDING DECEMBER 31, 1979.

BE IT ORDAINED by the Board of Trustees of the Town of Fort Branch, Indiana:

Section 1. The compensation of each Trustee of the Town of Fort Branch is fixed at \$ 2412.00 per year, said compensation to be paid monthly with equal amounts from the Town, Water Utility and Sewer Utility.

Section 2. The compensation of the Clerk-Treasurer is fixed at \$1704.00 per year payable by the Town General Fund, \$4008.44 at ~~\$4008.24~~ per year payable by the Water Utility and ~~\$4008.24~~ per year payable by the Sewer Utility, said Compensation to be paid semi-monthly.

Section 3. The Compensation of the Attorney of the Town of Ft. Branch is fixed at \$1800.00 per year, said compensation to be paid monthly with equal amounts from the Town General Fund, later utility and Sewer Utility.

Section 4. The Compensation of the Chief of Police of the Town of Fort Branch is fixed at \$9600.00 per year payable by the Town General Fund, said Compensation to be paid semi-monthly. The Compensation of the Second Marshall of the Town of Fort Branch is fixed at \$3240.00 per year payable by the Town General Fund, said Compensation to be paid semi-monthly. Each Marshall shall work seventy-two (72) hours and off duty seventy-two (72) hours and be subject to call to duty in case of an emergency.

Section 5. Clothing Allowance for each Marshall is fixed at \$25.00 per month, payable by the Town General Fund, said allowance to be paid monthly. Clothing Allowance for each Deputy (up to 3 Deputies) is fixed at \$15.00 per month, payable by the Town General Fund, said allowance to be paid monthly.

Section 6. The Compensation of the Street Commissioner is fixed at \$4370.40 per year, said Compensation to be payable semi-monthly from the Motor Vehicle Highway Street Fund.

Section 7. The Compensation of the regularly hourly worker is fixed at \$4.00 per hour, said compensation to be paid semi-monthly.

Section 8. The Compensation of the extra hourly workers is fixed at \$3.10 per hour, said compensation to be paid semi-monthly.

Section 9. The Compensation of the Office Clerk is fixed at \$3.30 per hour, said compensation to be paid semi-monthly.

Section 10. The Compensation of the Sewer Supt. is fixed at \$6037.65 , said compensation to be paid semi-monthly.

Section 11. The Compensation of the Appointed Member of the Water Board is fixed at \$76.00 per month, said compensation to be paid monthly.

Each Marshall shall work a designated shift & shall be subject to call to duty in case of emergency.

Section 12. The Compensation of the Water Dept. is fixed at \$16,390.00 per year, said compensation to be payable semi-monthly. The Compensation for performing duties of the Water dept. is fixed at \$32.64 per day, said compensation to be payable semi-monthly.

Section 13. The Compensation for male supervision at the Fort Branch Park is fixed at \$1.30 per hour and the compensation of the female supervision at the Fort Branch Park is fixed at \$0.60 per hour, said compensation to be payable semi-monthly or monthly.

Section 14. The Compensation of the Animal Control Officer is fixed at \$603.00 per year, said compensation to be payable monthly.

Section 15. All regular employees of the town of Fort Branch shall be paid for, not to exceed six (6) days per year for sick leave, if not used this year does not accumulate and cannot be carried over from one year to next. That all regular employees be paid for eight (-) holidays each year, providing said employee are working at time of holidays, namely, New Years Day, Memorial Day, July 4th., Labor Day, Election Day, Armistice Day, Thanksgiving, and Christmas Day. All regular employees who have worked one year will be entitled to one week vacation with pay. Those who have worked their second year will be entitled to two weeks paid vacation. Vacations shall not exceed two weeks. Vacation time can not be accumulated from year to year and must be taken each year. Any employee shall be entitled to lay off and all accrued vacation pay for the year should said employee's employment be terminated. For the above accrued vacation pay to be paid, two weeks notice must be given before termination except when termination is by notice of the town board of employees death. If termination is by action of the town board of trustees of Fort Branch, two weeks notice is not required for the above pay.

Section 16. Health insurance coverage with major medical benefits and life insurance coverage in the amount of \$1,000.00 shall be furnished on all regular employees of the Town of Fort Branch, Water and Sewer on all regular employees of the Town of Fort Branch, Water and Sewer Utilities. The premium of said insurance coverage shall be shared as follows to wit: The Civil Town, Water and Sewer Utilities shall pay entire premium except five cents (.05) per employee per month. Each employee shall pay five cents (.05) per month. Said credit is received for any reason for premium paid the same shall be written off and said shall receive all credit received. The five cents (.05) paid by the employee in said credit shall not be retained by employer.

Section 17. The compensation of the Fire Chief and Fireman, the Fire chief of the Fort Branch Volunteer Fire Dept. of Fort Branch, Indiana is fixed at \$350.00 per year, said compensation to be paid monthly. The compensation of the Volunteer members of the Fort Branch Volunteer Fire Dept. of Fort Branch, Indiana is fixed at \$12.00 each fireman per each fire run made beyond the community limits into the territory which compensation to be paid quarterly. The said compensation of each fireman per each fire run made shall not apply to the Fire Chief and Fireman per each fire run made shall not apply to the Fire Chief and Fireman per each fire run made into the territory which compensation to be paid monthly. The Fire chief of the Volunteer Fire Department, similarly during the month of December, Volunteer Fireman's runs into the territory shall be reviewed. If the appropriation cannot furnish compensation of Fireman has sufficient funds available at the close of the fiscal year the Fireman shall be allotted \$15.60 for each run hunting a house or park, this compensation to include the normal compensation of \$12.00 per run.
