

ORDINANCE NO. 1996-3

AN ORDINANCE AMENDING ORDINANCE NO. 1995-4

---

BE IT ORDAINED by the Council of the Town of Fort Branch, Indiana as follows:

ARTICLE I.

Sections 4 and 5 of Ordinance No. 1995-4 of the Town of Fort Branch, Indiana, entitled "An Ordinance of the Town of Fort Branch, Indiana fixing the Compensation for Elected Officials and all appointed employees of the town of Fort Branch, Water and Sewer Departments for the Fiscal Year beginning January 1, 1996 and ending December 31, 1996", as amended, is hereby amended to read as follows:

Section 4. The compensation of the Town Marshal of Fort Branch is fixed at \$27,200.00 per year payable by the Town General Fund, said compensation is to be paid semi-monthly. The compensation of the second Marshal of Town is fixed at \$25,500.00 per year payable by the Town General Fund, said compensation is to be paid semi-monthly. The compensation of the third and additional Marshals is fixed at \$19,500.00 per year payable by the Town General Fund, said compensation is to be paid semi-monthly. No additional compensation is to be paid to the Town Marshal or the Second, Third or additional Marshals under Section 9 herein. Each Marshal shall work a designated shift and shall be subject to call to duty in case of an emergency. There shall be no more than five Reserve Police Officers, who are volunteers and shall work as determined by the officer in charge. The reserve officers shall receive a clothing allowance as set out in Section 5 below, and the reserve officers shall receive no other compensation.

Section 5. Clothing allowance for each full time marshal is fixed at \$50.00 per month, payable by the Town General Fund. The clothing allowance shall be paid directly to the Vendor from whom uniforms are purchased. Any unused amount of any Marshal's clothing allowance at the end of the year shall be paid to that Marshal. The clothing allowance for each reserve officer is fixed at \$50.00 per month, payable by the Town General Fund. The clothing allowance shall be paid directly to the Vendor from whom uniforms are purchased. Any unused amount of any reserve officer's clothing allowance at the end of the year shall not be carried over to the next year. However, any unused amount of any reserve officer's clothing allowance will accrue from month-to-month until the end of the year.

Each new full time marshal and each new reserve police officer shall receive an initial clothing allowance of \$ 250.00. The clothing allowance shall be paid directly to the Vendor from whom uniforms are purchased. Any unused amount of an initial clothing allowance at the end of 180 days shall not be carried over.

ARTICLE II.

All other provisions of Ordinance No. 1995-4, as amended, shall remain in full force and effect.

ARTICLE III.

This Ordinance shall be in full force and effect beginning March 6, 1996.
