RESOLUTION OF THE TOWN OF FORT BRANCH, STATE OF INDIANA, SEPTEMBER 15, 2004

NOW THEREFORE, the Town Council, Fort Branch, Gibson County, Indiana, having read and examined the Petition to Vacate said alley lying inside the corporate limits of the Town of Fort Branch, Indiana, having seen, read and examined the affidavit of publication by the South Gibson Star Times, and there being no persons present to object or remonstrate to the vacation of said alley as submitted.

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF FORT BRANCH, GIBSON COUNTY, INDIANA, that the platted alley lying inside the corporate limits of the Town of Fort Branch situate on the real estate hereinafter described be vacated, to-wit:

Beginning at the southwest corner of Lot No. 159 in said enlargement; thence East, along the south boundary of Lots No. 159 and 160 in said enlargement, to a point being 19 feet west of the southeast corner of said Lot No. 160; thence South to a point in the north boundary Lot No. 40 in the Original Plan of Fort Branch, Indiana, as per plat thereof recorded in Town Plat Book No. 1, page 53 in the Office of the Gibson County Recorder, with said point being 19 feet west of the northeast corner of said Lot 40; thence West, along the north boundary of said Lot 40, to the eastern right-of-way line of Railroad Street; thence Northerly, along said eastern right-of-way line, to the point of beginning.
